

Gardner Denver iConn Privacy Policy

Welcome to Gardner Denver iConn.

This Privacy Policy describes how Gardner Denver Inc., its affiliates, subsidiaries, and service providers, collects, uses, shares, and retains your personal information in connection with your use of the iConn portal. By using iConn, you agree to the collection and processing of your information as set forth in this Privacy Policy. Your use of iConn and any information you provide through or in connection with iConn is at all times subject to this Privacy Policy.

This Privacy Policy does not address how we use information about your organization's or Gardner Denver's equipment or components and products used in your products or manufacturing activities when you connect them to the iConn digital platform. Please see the iConn Terms of Service for information about such data.

Information We Collect

Information You Provide

We and our service providers may collect any information that you provide when you log in to and use iConn, including your name, your organization's address, your email address, your password, and any information you provide when you contact us.

Automatically Collected Information

We may also automatically collect certain technical information from the device(s) you use to access iConn over time and across different devices such as your IP address, your device ID, your ISP provider, your browser type, the pages you view on iConn, the pages you view immediately before and after you access iConn, date/time stamps, and the search terms you enter on iConn.

Cookies

We, and third parties, including our service providers, may collect this information using "cookies", web beacons, or similar technologies. iConn uses first party cookies (i.e. cookies set directly by us to your device) as well as cookies served by third parties for the purposes outlined below. Some of the cookies used by iConn only remain on your device while your browser is open (these cookies are known as "session cookies") while others remain for longer periods (these are known as "permanent cookies"). iConn uses the following cookies:

You have the right to choose whether or not to accept cookies. However, they are an important part of how iConn works, so you should be aware that if you choose to refuse or remove cookies, this could affect the availability and functionality of iConn.

Most web browsers are set to accept cookies by default. If you prefer, you can usually choose to set your browser to remove or reject browser cookies. To do so, please follow the instructions provided by your browser which are usually located within the “Help,” “Tools” or “Edit” facility. Some third parties also provide the ability to refuse their cookies directly by clicking on an opt-out link, and we have indicated where this is possible in the table above.

How We Use Information

We use the information we collect to provide our services, including to provide you with information that you request. We also use the information we collect to improve iConn, including by generating and analyzing statistics about your use of iConn.

We may use the information we collect and receive to protect our rights and to detect, prevent, and respond to fraud, intellectual property infringement, violations of law, or other misuse of iConn.

We use the information collected from cookies and similar technologies to for example, generate statistics and measure activity on iConn, to improve the iConn interface, and to keep you logged in so you do not have to re-enter your login credentials as you use iConn.

How We Disclose Information

We share certain information that we collect or receive to provide the services that you have requested, when we have your consent, with our affiliates, subsidiaries, and with other third parties and otherwise as described in this Privacy Policy.

We may use third parties such as service providers to help power iConn. We may share information with such service providers to provide the services that you request or that provide services to Gardner Denver in connection with our business operations.

We may share information in association with the consideration, negotiation, or completion of a corporate transaction in which we are acquired by or merged with another company or we sell, liquidate, or transfer all or a portion of our assets.

We may disclose your information to third parties as required by law or regulation and when we have a good faith belief that it is necessary in order to protect the legal rights, safety, and security of Gardner Denver, our affiliates, our business partners, users of iConn and others; to prevent fraud or for risk management purposes; and to comply with or respond to law enforcement or legal process or a request for cooperation by a government or other entity.

We may share information that is not reasonably identified with you for any purpose.

Consent to Transfer of Personal Information Outside Your Home County

Your submission of information on iConn may result in your information being stored in the United States or in other countries that may not require the same level of protection for your information as your home country. By submitting your information through and using iConn, you acknowledge and agree to the provision and processing of your information in the United States or other countries for the purposes described in this Privacy Policy.

Safeguarding Your Information

We implement administrative, technical, and physical safeguards designed to safeguard the information collected through iConn.

Data Retention

We may retain information that can reasonably identify you for as long as your account is active or as we determine is appropriate for our reasonable business purposes, including, for example, to comply with our legal obligations, resolve disputes, and enforce our agreements.

Changes to this Policy

If we update this Privacy Policy, we will notify you by posting a new Privacy Policy. If we make any revisions that materially change the ways in which we use or share the information previously

collected from you through iConn, we will make reasonable efforts to notify you of such changes. Your continued use of iConn after changes to the Privacy Policy indicates your acceptance of the new policy.

Your Rights

You may request information about the personal information stored about you and your use of iConn free of charge and have the right to request us to correct, block and delete your personal data in accordance with the applicable legal regulations.
